Expense Schedule

- A. The appearance sponsor of Miss Michigan will pay a round trip fee of \$.55 per mile from her hometown/living location to place of appearance.
- B. The appearance sponsor is responsible for lodging and meals for Miss Michigan and her traveling companion. The appearance sponsor shall assume expenses and pay for same. (One room double occupancy/ non-smoking)
- C. Any additional expense incurred while traveling and during appearance will be billed with the appearance mileage fee. (parking charges etc)
- D. The **non- refundable \$25.00 booking fee must accompany the return of the appearance contract to secure your placement (please call should you have any concerns)** to secure the appearance date.

Billing

- A. You will receive a statement for appearance fee, mileage and any additional expenses, one to two weeks before the event.
- B. The statement is due and payable upon receipt.
- C. There is a \$ 25.00 late fee applied for any outstanding payments not received within 15 days of the dated invoice.

Rules & Regulations for Miss Michigan Appearances

- A. Miss Michigan shall be introduced as "Miss Michigan" or Michigan's Representative to the Miss America Pageant"
- B. Miss Michigan is restricted to 6 working hours per appearance. This appearance should be scheduled between the hours of 9:00 AM and 11:00 PM
- C. Miss Michigan's appearance must be confined to the company or organization sponsoring the appearance.

Securing an appearance date:

- D. To secure appearance date: please enclose the \$25.00 booking fee

- E. Include a Map of the appearance location. Please provide written directions.



Refund Policy:

1. The booking fee is non-refundable.
2. A refund will occur on the following occasion(s):
 - a. Illness or medical/family incident with Miss Michigan (you will be notified as soon as possible)
 - b. Any cancellations due to an act of nature or weather
 - i. 50% due to weather or relocation
 - c. Cancellation of pageant or program
 - i. 0% if notified (within) one week of booking the event
 - ii. 50% if notified four weeks of event
3. Should Miss Michigan need to cancel you will be notified and the following options will be discussed:
 - a. Replacement of the current Miss Michigan with a former or the 1st Runner Up
 - i. Cost will be discussed at that the time of booking and an acceptable mutually agreed upon fee will be issued
 - ii. Due to cancellation, any materials/posters etc. generated for the appearance of Miss Michigan: the Miss Michigan Scholarship program will not be responsible for replacement cost of generated materials.
